



Allora USA Limited Warranty – Faucets & Fittings

1. General Terms

Allora USA warrants its products to be free of defects in material and craftsmanship under normal use for the specified periods. This warranty applies only to products purchased and installed within North America.

This warranty applies to only the original buyer and is not transferable unless the product was bought by a plumbing service provider. In this case, the warranty will extend exclusively to the first property owner for whom the product was originally installed.

2. Exclusions

Allora USA's responsibilities under this warranty are limited to either repair or replacement of the product or any component. At its sole discretion, Allora USA may exchange the product for an identical or comparable model. Allora USA reserves the right to conduct any inspections it considers necessary.

Allora USA is not responsible for any:

- I. Damage caused by incorrect installation, misuse, or improper maintenance.
- II. Damage that occurs during shipment.
- III. Indirect or consequential damage to personal or real property.
- IV. Costs related to shipping, labor, or installation/replacement.
- V. Damage from harsh conditions or corrosive cleaning agents.
- VI. Normal wear, such as the natural aging of finishes over time.
- VII. Compliance with local building codes. Buyers are advised to consult a local plumbing contractor to ensure compliance before installation.

VIII. Failure of the product due to external forces, such as vandalism or impact.

3. Actions that Void the Warranty

- I. Removing the product from the initial place of installation.
- II. Improper maintenance, abuse, misuse, improper use, accident, fault or negligence.
- III. Installation that is different from the installation instructions.
- IV. Purchase from an unauthorized seller.
- V. Damage, whether accidental or intentional.
- VI. Usage in an unintended application.
- VII. Improper shipping, storage, or handling.
