4. First-aid Measures

FIRST AID - EYE CONTACT: Immediately flush eyes with plenty of water for at least 15 minutes holding eyelids open. Get medical attention. Do NOT allow rubbing of eyes or keeping eyes closed.

5. Fire-fighting Measures

6. Accidental Release Measures

Store large quantities in buildings designed and protected for storage of NFPA Class I flammable liquids. Product should be stored in tightly sealed containers and protected from heat, moisture, and foreign materials. Store in a dry, well ventilated place. Keep container tightly closed when not in use. Keep away from heat, sparks, flame and sources of ignition. Avoid excess heat.

8. Exposure Controls/Personal Protection

PERSONAL PROTECTION

ENGINEERING CONTROLS: Use explosion-proof ventilation equipment. 10. Stability and Reactivity

CONDITIONS TO AVOID: Avoid temperatures above 120°F (49°C). Avoid all possible sources of ignition. Avoid contact with strong acid and strong bases.
